TOURNAMENT SYSTEM: Double Elimination. // Seniors Double elimination with 6 or more, 5 or less round robin.

4. Tachi Waza only (Standing Judo Only)
5. 5 or less round robin, 6 (2 divisions of 3), 7 (pool A 4 athletes and pool B 3 athletes), 8 (pool A 4 athletes & pool B 4 athletes), 9 (Pool A 5 athletes and Pool B 4 Athletes)
6. 10 and up athletes pools will be split example (5 in pool A and 5 in pool B) winner of Pool A will fight loser of pool B and winner of Pool B will fight loser of Pool A winners will face each other for Gold and Silver and losers will face each other for Bronze.

In consideration of being permitted to participate in any way, including travel to and from, Florida Open Judo Championship _____, and related events and activities of United States Judo, Inc., United States Judo Federation, United States Judo Association, Florida Judo Inc., and **Somerset Academy, City of Coral Springs, Coral Springs Gymnasium and Panther Judo Club**, I hereby:

1. Acknowledge that I am familiar with the sport of Judo and understand the rules governing the sport of Judo.
2. Agree that prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.
3. Acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, including permanent disability or death, and severe social and economic losses due to not only my own actions, inactions, or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages following such injury, permanent disability, or death.
5. Release, waive, discharge and covenant not to sue the United States Judo, Inc.
