will determine the age for the meet (the first day of competition at the Junior  
Olympics)

2<sup>nd</sup>, and 3<sup>rd</sup> place medals will be awarded to exhibition swimmers. Please  
be sure to mark exhibition when appropriate.**

Relays: Custom medals 1<sup>st</sup> 2<sup>nd</sup> & 3<sup>rd</sup>.

\*\*\*Heat awards\*\*\* Heat ribbons will be given to all heat winners.

\*\*\*Awards MUST be picked up by the coach or team representative.

**BULLPEN:** Swimmers must check in with the clerk of the course 30 minutes prior to the start of the meet. It is the swimmer's responsibility to report promptly to the Bullpen when their event is called. In the bullpen, the swimmers will be given cards and lane assignments.

**SCORING:** Individual: 9-7-6-5-4-3-2-1 Relay: 18-14-12-10-8-6-4-2  
All events will be timed finals.

**RULES:** All sessions will be run by NO FALSE START RULE. USA swimming rules will be followed.
